Information is recorded in a block.



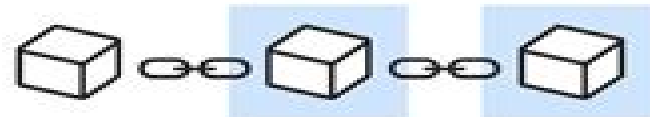
